**MINUTES**

**I. Call To Order**

Interim Mayor Carson called the meeting to order at 7:05 p.m.

**II. Roll Call**

**Members Present:** Interim Mayor Chris Carson, Vice Mayor Dan Hunt, Council Member Rick Dwyer, Council Member Lita Handy-Peters, and Council Member Sid Vihlen, Jr.

**Others Present:** City Manager Dan Parrott, Assistant City Manager Kassandra Blissett, City Clerk Stacy Tebo, Finance Director Liz Bauer, and Parks and Recreation Director John Fletcher

**III. Public Participation For Any Issues Not On the Agenda** - Citizen comments are limited to three minutes per speaker.

Morton Culligan addressed the Council.

**IV. Additions, Deletions, or Amendments to the Agenda**

Council Member Dwyer said he had questions regarding Ordinance #08-14 and asked that it be tabled due to the absence of City Attorney Kurt Ardaman. Council Member Vihlen moved that the item be continued until October 1<sup>st</sup> at 7:00 p.m. Council Member Handy-Peters seconded, and the motion passed unanimously.

**V. Public Hearings**

1. Resolution #14-16 – Adopting a Final Millage Rate for Fiscal Year 2014/2015.

Mr. Parrott read Resolution #14-16 aloud by title. Council Member Handy-Peters moved to adopt Resolution #14-16 adopting an ad valorem millage rate of 2.9247 for fiscal year 2104-2015. Interim Mayor Carson seconded, and the motion passed unanimously.

2. Resolution #14-17 – Adopting a Final Budget for Fiscal Year 2014/2015.

Mr. Parrott read Resolution #14-14 aloud by title. Council Member Handy-Peters moved to adopt Resolution #14-17. Interim Mayor Carson seconded.

Council Member Dwyer made an amended motion to approve Resolution #14-17, but move existing line items of approximately \$82,200 to the stormwater management budget. Council Member Vihlen seconded for discussion. The amended motion failed 2-3, with Vice Mayor Hunt, Interim Mayor Carson, and Council Member Handy-Peters dissenting.

Interim Mayor Carson called for a vote on the original motion to approve Resolution #14-17 as presented. The motion passed 4-1, with Council Member Dwyer dissenting.

3. Ordinance #08-14 – First Reading – Amending Chapter 2 of the Code of Ordinances to Authorize the Special Master and City Manager to Expedite the Lien Reduction Process.

This item was tabled until October 1<sup>st</sup> at 7:00 p.m.

#### **VI. New Business**

1. Rob Sullivan Park West Parking Lot Drainage Repair.

Council Member Vihlen moved to fund up to \$7,300.00 (alternative #1) for the long-term solution to correct the erosion concerns at Rob Sullivan Park West Parking Lot. Council Member Dwyer seconded, and the motion passed unanimously.
