V. Discussion Items

1. Direction to Charter Review Commission

The Council expressed reluctance to change the Charter but agreed to review recommendations made by the Charter Review Commission.

2. Review Small Scale Storm Water Projects

There was consensus to address the stormwater projects recommended by David Hamstra to alleviate structural flooding.

3. Review and Discuss CRA/Brownfield Project

There was consensus to wait on the CRA issue until Volusia County's stance on future CRA approval is known. There was consensus to move forward with the Brownfield Project.

4. Review Dollar General Development Issues

Council discussed required variances and the consensus was to favorably consider the variances.

5. Name for Splash Park

No decision was made.

6. Share a Book Program

The Council was appreciative of the effort by Mrs. Polensky but the consensus was to decline the request.

7. Gazebo Improvements

The Council instructed staff to develop a plan and cost estimate to provide a sound system for the Gazebo.

8. Volusia Titans Football Team

The Council was supportive of providing a field at Rob Sullivan Park. Council instructed staff to apply for an ECHO Grant for irrigation.
