**I. Call To Order**

Mayor Garcia called the meeting to order at 7:05 p.m.

**II. Roll Call**

**Members Present:** Mayor Bob Garcia, Vice Mayor Chris Carson, Council Member Lita Handy-Peters, Council Member Dan Hunt, and Council Member Nick Koval

**Others Present:** City Manager Dan Parrott, Assistant City Manager Cassandra Blissett, and City Clerk Stacy Tebo

**V. Public Hearings**

1. Resolution #13-18 – Adopting a Final Millage Rate for Fiscal Year 2013/2014.

Mr. Parrott read Resolution #13-18 aloud by title. Council Member Hunt moved to approve Resolution #13-18, adopting an ad valorem tax rate of 3.055 for FY 2013/2014. Council Member Koval seconded. The motion passed 4-1, with Mayor Garcia dissenting.

2. Resolution #13-19 – Adopting a Final Budget for Fiscal Year 2013/2014.

Mr. Parrott read Resolution #13-19 aloud by title. Council Member Koval moved to approve Resolution #13-19, adopting the Annual Operating Budget for FY 2013-2014. Council Member Handy-Peters seconded. The motion passed 4-1, with Mayor Garcia dissenting.

**VI. New Business**

1. Proposal for Mosaic Hopscotch Court and Memorial Bricks at DeBary Community Park.

Council Member Koval moved to approve the proposal for the mosaic hopscotch court and memorial bricks as presented by Ms. Blissett. Vice Mayor Carson seconded. The motion passed unanimously.

2. Consideration of FY 2013-2014 Volusia TPO Membership Assessment and Funding Agreement.

Council Member Hunt moved that the City enter into the FY 2013/2014 funding agreement with the Volusia TPO and allocate \$1,934 for such membership. Council Member Handy-Peters seconded, and the motion passed unanimously.

3. Consideration of Interlocal Agreement with Orange City for Municipal Animal Services.

Council Member Koval moved that the City enter into the Interlocal Agreement for animal control services with the City of Orange City effective November 1, 2013, contingent on Volusia County agreeing to the termination of the existing contract. Vice Mayor Carson seconded. The motion passed unanimously.
