We understand that we will be charged for these connect / disconnect services, and any and all other charges that may be billed by either Florida Power and Light Corporation (FPL) or Florida Power Corporation.

We, the undersigned, agree to the terms set forth above on this the _____ day of _____ 20____, in the City of DeBary, Volusia County, Florida. Further, we certify that the wiring electrical apparatus, fixtures, etc., of the entire building are in such condition, i.e., protected and isolated, that electrical current may safely be connected. We agree to hold the City of DeBary, its agents, employees and officers harmless to the fullest extent against any claim of any nature arising out of the operation of this Agreement.

Further, we the undersigned understand and agree that approval of this request does not constitute approval of occupancy of this structure for any purpose whatsoever and that occupancy can only be obtained after final completion of the entire structure, parking, landscaping, engineering and environmental items. The undersigned, jointly, appoint the City of DeBary Building Official our attorney in fact, granting to said Building Official power of attorney to cause electric service to be disconnected as he may deem necessary in his sole discretion.
