COMMUNITY PARK SPLASH PAD

137 S. HWY 17/92



- ◆ The Splash Pad is open from Volusia County Spring break until the end of October.
- ◆ Hours of Operation: 10 AM to 6 PM.
- ◆ The Splash Pad is **closed on Mondays** for maintenance.
- ◆ Groups of more than 30: Tuesday and Thursday only (1:00pm-3:00pm)
- ◆ The Splash Pad is unsupervised. **Play at your own risk.**
- ◆ ALL children under the age of 10 must be accompanied by an adult and have adult supervision at all times.
- ◆ Food and glass containers are not permitted on Splash Pad.
- ◆ No pets allowed on the Splash Pad.
- ◆ Swim diapers are required for all children under 4 years old.
- ◆ Roughhousing, violent play, alcohol and tobacco are prohibited.
- ◆ Be mindful of inclement weather. Pad shall be vacated at first sign of inclement weather.
- ◆ Athletic equipment, balls, bats, beach balls, noodles, skateboards, bikes, etc. are not allowed on the Splash Pad.
- ◆ Maximum capacity for the Splash Pad is 70.
- ◆ Admission is free. There are no rentals at this park. All amenities are first come first serve.

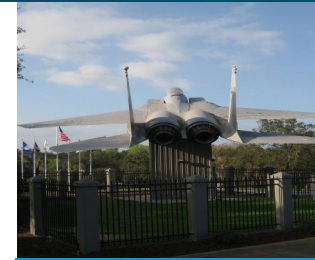

An individual or organization may only have one scheduled rental on the books at a time. All pavilions and fields are first come first serve when not reserved. No restroom facilities at River City Nature Park, Power Park, Memorial Park, Alexandra Park, and Eagles Nest Park.

If admission is to be charged to an event on City property, the City will require 15% payment from the admission and concession proceeds. This will be in addition to the fees charged for the use of the facility. A Special Event Permit is required.
